### A. FIGs

I would like us to review the form so that we have a clear understanding of what is expected of FIGs. At this time, it seems PLC wanted to make a clear commitment to ISTs since they were created with SEA 2.0 in mind (our campus's equity plan).

  - i. Some believe we do not give enough money for conferences
  - ii. Part-time employees currently get less money
  - iii. More money was approved for adjuncts to be the same as the amount given to full-time faculty
  - iv. Amber Gonzalez
    - 1. Approved
    - 2. National Association for Chicano and Chicana Studies
  - v. Lyman Medeiros
    - 1. Provisional approval
    - 2. Resubmit for higher funding, adjunct faculty can now receive up to \$2K
    - 3. Dissemination plans need to be formalized
  - vi. Sustainability FIG
    - 1. This FIG is a continuation of previous work. The previous Staff Dev Coordinator let them know to reapply.
    - 2. Comparing this FIG with the updated version of the FIG form
    - 3. Used older version of FIG form, as it was a continuation of the last semester they did work on this FIG. As is, this FIG needs to be resubmitted to be in line with ISTs. It will be revised and voted on at a later meeting.
